Superintendent Evaluation Policy and Procedure

As the KSBA Policy Service processes changes to each board's superintendent evaluation policy and procedure, districts are being reminded to send a copy of those documents to Larry Stinson at the Kentucky Department of Education (KDE). Based on newly revised KRS 156.557, which took effect on July 15, "Each superintendent shall be evaluated according to a policy and procedures developed by the local board of education and approved by the department."

The Policy Service will notify each district we work with whether their policy and/or procedure is consistent with the KSBA model and, if it is, the notification to KDE should note that. KDE has indicated documents built on the KSBA models will be approved.

Suicide Prevention Training

SB 65 - Suicide Prevention Education for Middle and High School Staff was signed by Gov. Steve Beshear on April 13. This bill amended KRS 158.070 to require all high school and middle school principals, guidance counselors and teachers to complete a minimum of two hours of selfstudy review of suicide prevention materials each school year. It also amends KRS 161.011 to permit suicide prevention training for classified employees.

Note: Although SB 65 does not designate a deadline for the mandatory training, the Department for Behavioral Health, Developmental and Intellectual Disabilities and the Kentucky Department of Education recommend that staff training be completed prior to dissemination of suicide prevention materials to students.

HB 51 - Suicide Prevention Information for Middle and High School Students was signed by Governor Beshear on March 4, 2010. This bill amended KRS 156.095 to require the Cabinet for Health and Family Services to post suicide prevention awareness and training information on its website by Aug. 1, and to require every public middle and high school administrator to disseminate suicide prevention awareness information to all middle and high school students by Sept. 1, 2010, and Sept. 1 of each year thereafter. Policy Q & A

Q. Does the superintendent's evaluation have to be "adopted" and acted upon during a board meeting?

A. Yes. New language in KRS 156.557, which was amended by the 2010 General Assembly and took effect July 15 requires that: "The summative evaluation of the superintendent shall be discussed and adopted in an open meeting of the board and reflected in the minutes." Adoption requires taking action with a motion, second and vote.

Budget Tight?

Funding continues to be a challenge for school districts across the state. If you are looking for money-saving ideas, the KSBA policy staff suggest the following:

• Reduce the number of paper-copy sets of policies and procedures that KSBA maintains for your district. In addition to saving staff time spent replacing revised pages throughout the school year, your district can save \$30 per set per year for copying/mailing of policy sets and \$25 per year for administrative procedure sets.

• Use your online manual service from KSBA, rather than making paper copies for use during discussions by the board or student/staff/parent orientation and training sessions.

• Free up staff time and promote awareness of board policy provisions by *subscribing to the KSBA Employee and/* or Substitute Teacher Handbook Service, which will provide you with an electronic copy of your district's handbook(s) to be posted on your school/district website.

• Free up even more staff time and also save money over time through the KSBA eMeeting Service, rather than relying solely on paper board-meeting packets.
