REQUIRED ANNUAL NOTICES

One of the many challenges public school districts face is meeting the requirement to provide numerous legal notifications to various audiences (staff, students, parents, public). Among the many legally required annual notices are the following requirements that may not be familiar to district staff:

Homeless Students

Federal law (McKinney-Vento Act) requires the staff member designated to serve as liaison to homeless children and youth to provide public notice of the education rights for those students in places where homeless students receive services under the Act (42 U.S.C. § 11432g.6). Asbestos Management

Federal law (Asbestos Hazard Emergency Response Act/AHERA) also requires school districts to annually give written notification to parents, teachers, and employees of the availability of an asbestos management plan and current/planned inspections and response actions (40 C.F.F. §§ 763.84c, 763.94g.4). Districts can download a free yearly notification form provided by the U. S. Environment Protection Agency (EPA) at:

PERFORMANCE-BASED CREDIT

- **Q** Is it possible for a student to take a night computer class, receive dual (high school and college) credit for that class, and the district still receive ADA funding?
- A Yes, a student may attend a dual credit class that meets at night, and the district would still receive ADA as long as board of education policy allows it. However, districts cannot generate more than 100% ADA for a student, so the night class will displace a class in the regular schedule for ADA calculation purposes. If the school decides that the student is not required to be present at the school for that period, appropriate parental permissions and liability issues should be addressed.
- **Q** We have a high school student that will be attending the Academy of Mathematics and Science at Western Kentucky University. What policy changes will our board need to consider?
- A Although there may be other policy areas affected, your board policy on graduation requirements needs to reflect that performance-based credits will apply toward graduation. Your board also may want to consider including/adding dual credit language to their 08.1131/Alternative Credit Options policy and/or related procedure if the district wishes to allow students to earn credits in that manner.
