### Waiver of March 1 allocation notification for 2009-10

On Feb. 11, the KSBA Policy Service notified all superintendents about action by the Kentucky Board of Education to extend this year's deadline from March 1 to May 1 for notifying school councils of 2009-10 allocations. As a result, districts are advised to review all dates/deadlines stated in policies 02.4331 and 02.4242. If your board policy 02.4331 requires councils, after receiving their allocation notice, to report back to the board by a certain date (example, March 31) the number of persons to be employed in each job classification, be advised that in setting any new "report back" timeline for councils, a district needs to keep in mind statutory deadlines for personnel action. If personnel action is necessary following council action, the district must leave itself sufficient time to comply with those personnel deadlines.
