Update preview

Following adjournment of the 2009 General Assembly, the KSBA Policy Staff is hard at work preparing update recommendations for your policies and procedures, based on the latest statutory and regulatory changes and best practice recommendations. The updates will be e-mailed to the superintendent/policy contact of each member district. Here are selected bills that passed the General Assembly that will affect your policies and procedures.

Spring has sprung - school facilities in demand

KSBA Risk Management staff have confirmed that the spring and summer months often bring an increase in requests from outside groups to use school district facilities (gyms, cafeterias, grounds, etc.). In response to such requests, it's always a good idea to check your board's policies and procedures on community use of school facilities (05.3/05.31) to make sure appropriate steps are followed, from who approves requests to what conditions must be met. Of particular importance is full compliance with liability, insurance, and supervision requirements.

FACTA - use of credit agencies

Recent rules and guidelines implementing sections of the Fair and Accurate Credit Transaction Act (FACTA) of 2003 pertaining to identity theft red flags and address discrepancies have only limited application to school districts. These new requirements mean users of consumer reports must implement policies for responding to a notice of address discrepancy from a credit report agency.

If your district regularly uses credit report agencies to conduct background checks on applicants for certain positions, please contact your KSBA policy consultant to discuss policy implications.
