COMING IN YOUR MAY UPDATE

At this time, it appears that each district's update will contain approximately 45 policy drafts and, for procedure service subscribers, 20 procedure drafts. In addition to several areas affected by action of the 2013 General Assembly, following are key areas that will be addressed:

Graduation Requirements (08.113)

Your board's graduation policy 08.113 may include several recommended changes, including the following:

Consistent with the district's graduation practices for all students, an alternative high school diploma shall be awarded to students with disabilities in compliance with Kentucky Administrative Regulation. In addition, former students may submit to the superintendent a request that the district provide them with an alternative high school diploma to replace the certificate of attainment they received at time of graduation from the district.

Alternative Education (09.4341)

Your board's policy in this area basically will be redesigned to reflect new regulation, 704 KAR 19:002. In addition to an essentially new policy 09.4341, a sample administrative procedure, 09.4341 AP.21, also will be provided to procedure service subscribers.

Suggested Policy Changes based on State Auditor Recommendations

Areas affected will include travel expense reimbursement (01.821/03.125/03.225), use of school property (03.1321/03.2321), salaries (03.121/03.221), review of credit card transactions (04.31) and warrants or orders of the treasurer. (04.3111).
